STATISTICS OF DUAL VET GRADUATES

Annually, the Ministry of Education and Research of the Republic of Moldova finance from the state budget **8,000 places** for the entire VET system, including up to **1,500** places for approximately **50 educational programmes** through Dual VET system based on the private sector needs.

More than **25 VET institutions** currently train the qualified specialists through dual VET programmes in cooperation with **140 local and foreign private sector companies**.

The **employability rate** of the Dual programmes graduates is more than **70%** in the first **6** months.

From 2015 till 2023 around **4,400 young people graduated** dual VET programmes.
