







Q LOCATION

Situated in the southern part of the Republic of Moldova, Gagauzia is bordered by the Ukrainian district of Odessa to the East and has administrative border with districts of Leova, Cantemir, and Cahul to the West. By car, it takes 1.5 hours to travel from the capital of Gagauzia, Comrat, to the capital of Moldova, Chisinau. Its location in the South of Moldova is close to the Danube ports of Giurgiulesti (International Free Port, Moldova), and to the river ports of Galati (Romania), Reni and Ismail (both Ukraine).

GENERAL OVERVIEW OF THE AGRICULTURE SECTOR

With its favorable climate and geographical conditions, rich soils and biological diversity, agriculture is the main economic pillar of the Gagauz region.

In 2021 the value of agriculture production was approximately 2.2 billion MDL. Together with the processing industry it represents more than 72 percent of the region's Gross Domestic Product. More than 29,9 percent of the labor force is involved in those two sectors. The total area of agricultural land in the Gagauz region is about 150 thousand hectares.


Fields for multi-annual crop production make up for the largest part of arable land.

Much of it consists of highly fertile and productive black chernozem soils.

Rich soil resources support a wide array of annual and perennial crop production across the Autonomy.

Major agriculture products are grains, leguminous plants, oilseeds, and wine grapes. Animal production ensured 14,8% of the total gross value of the agriculture production.


The volume of agricultural production in all categories of farms and in the associated sector, for 2016-2022 (million MDL)

MAIN SUBSECTORS OF AGRICULTURE AND FOOD PROCESSING INDUSTRY

Plant growing has the largest share within the structure of agricultural production. Its share in the total agricultural production is more than 85,2%. The animal production reached a value of 14,8% (214 million MDL) in 2022.



VINE AND WINE



Wine-making is an essential branch of the economy. In the structure of agricultural land of agricultural enterprises, the share of vineyards accounts for 4.7% of the area (5379 hectares), including 4561 hectares in the fruiting age, which provide about 13% of the value of agricultural products of agricultural enterprises.

In 2022, vineyards were planted on area of 47,6 hectares, including 4,8 hectares of non-technical varietes and 42,8 hectares of technical varietes.

Planting was carried out by certified seedlings of intensive European technical and non-technical varieties.

Total exports registered in 2022 value approximately 2915,9 million MDL. The main export destinations are the Romania, Turkey, Russia, Philippines, Italy, Bulgaria, Germany, Iraq, Ukraine, Switzerland, Netherlands, Pakistan.

FRUIT AND VEGETABLES PROCESSING

Gagauzia features the natural conditions necessary for an intensive development of horticulture.

Fruit-growing represents a strategic branch of the local economy, accounting for around 4,1 percent of the agricultural production value.

As part of the implementation of programs for the development of horticulture and viticulture in Gagauzia, in 2022, orchards with a total area of 188,7 hectares were planted in the autonomy.

One of the main exported agricultural products are fruits and vegetables. In 2022 the total value of exported fruits, vegetables, and walnuts was more than 26,1 million MDL. Overall Gagauzia has very good conditions for producing horticultural crops.

The fruit processing segment is developing dynamically so far in regards to cold stores for cooling and further shipment of apples, grapes, plums, and peaches. The infrastructure for processing and cold storage of fruits and table grapes in Gagauzia is represented by nine refrigerated warehouses with a total storage capacity of up to 5600 tons.

LIVESTOCK AND DAIRY

Between 2006 and 2022, cattle livestock decreased by 46%, the number of pigs decreased by 27%, and sheep and goats decreased by 17%.

The decrease in livestock numbers was the result of inefficient restructuring of large cattle farms, as well as the lack of funds for investment in modern livestock facilities. Currently the livestock sector, providing food independence of the region, is underdeveloped. This is also due to the lack of external markets for livestock products, slaughterhouses and refrigeration facilities. There is a large potential for investment in the livestock sector in the region, and especially in livestock farms.

INTERNATIONAL TRADE


The main trade partners for export of agri-food products are EU, CIS, Turkey and other countries.

During the last years, agri-food exports have had a stable growth trend. Nevertheless, the promotion of agricultural exports should have a clear sectorial focus. Financing the promotion of agricultural exports should be clearly assessed through monitoring and systematic analysis of the markets and indicators of the effectiveness of used budget funds.


The agro-food trade had a positive balance of 369 million MDL and the share of agri-food exports in total exports represents 12,7% (2022), while the share of agri-food imports in total imports stands at just 2,2% (67,1 million MDL).

The main export products are wine and spirits, sunflower, wheat, table grapes, fruits and walnuts. Oil seeds and fruits, cereals, potatoes, live animals, fruits and nuts have the largest share in total imports of agricultural products.

The total volume of wines and spirits exports was 762,6 million MDL, which represents 26,2% of the total value of agro-food exports.

ECONOMIC COOPERATION

The Republic of Moldova has signed 43 Free Trade Agreements (FTA), all of them are valid also for Gagauzia, including:

INVESTMENT OPPORTUNITIES AND PREFERENCES

The local legislation provides a large range of options for investors. The regional law on investments gives investors additional guarantees and benefits. Investment preferences are applied in agriculture and industry. Targeted preferences are provided in accordance with the legislation of ATU Gagauzia to investors implementing an investment project for a period of not more than five years.

Investment incentives



Agricultural subsidies (additional to national subsidies) – reimbursement of procured agricultural equipment and technological re-equipment, planting material, procurement of breeding animals from certified farms.



Investment subsidies – reimbursement of up to 30% of investments but limited to 5 million MDL (ca. 250 000 EUR) of the actual costs for construction and installation works, purchasing of equipment without VAT;

Reimbursement is made in the following order:

- a) with actual expenses from 1,000,000 lei to 2,000,000 lei, 10% is reimbursed;
- b) with actual expenses from 2,000,000 lei to 3,000,000 lei, 20% is reimbursed;
- c) with actual expenses of 3,000,000 lei and more, 30% is reimbursed, but not more than 5 million lei.



Job creation subsidy - provision of 20 000 MDL (ca. 1000 EUR) for each new created job. The main criteria is to create 10+ jobs in manufacturing industry;

The Moldovan regulations on intervention and subsidies in agriculture are fully applicable in the region. The regional infrastructure is well developed. The road infrastructure provides access to the production sites, public utility services are widely spread and accessible.

VITICULTURE AND WINE INDUSTRY INVESTMENT OPPORTUNITIES

Advantages

Local legislation provides a large set of possibilities to investors and their newly opened businesses.

The regional infrastructure is well developed. The road infrastructure permits access to production sites, all types of utilities are widespread and can be easily accessed.

Geography

Natural factors of Moldova as a combination of a unique microclimate (a favorable mix of sun, rain, and temperature), fertile soil, favorable geographical position on the same latitude as France and Northern Italy.

Climatic conditions of the region are characterized by an annual rainfall of approximately 479 mm and an average annual temperature of 12°C

Traditions

Viticulture and winemaking is an activity that has been practiced in Moldova over millennia.

New wines

The wine produced in the Autonomy has won international recognition.

Frequent winners of international wine competitions are wines produced in Gagauzia, such as: Chardonnay Gagauzia Wines, Dor Merlot-Saperavi, 98 Hectares Feteasca Neagra, Alb de Onițcani, Plai Saperavi Bastardo, etc.

The region is also famous for its ordinary and sparkling wines.



FEZ "Valkanes" was established in 1998. It is located in Vulcanesti city and includes two subzones in municipalities of Comrat and Ceadir-Lunga. The total area of FEZ "Valkanes" is circa 200 hectares, namely in Vulcanesti City — 107 hectares, Comrat Municipality — 50.3 ha, and Ceadir-Lunga Municipality — 42 ha.



WHY INVEST IN THE AGRICULTURE SECTOR OF GAGAUZIA?

- Stimulating investments through the Agricultural subsidization fund under the Law on principles of subsidizing agricultural producers of ATU Gagauzia No 19-IX/VI of December 8, 2017. The amount of the subsidy is determined by the Regulation on the use of resources of the Agricultural subsidization fund of ATU Gagauzia and is provided for each support measure, namely:
- Production of Fruits and Vegetables stimulating investments in the production of fruit and vegetables in closed ground (greenhouses, hotbeds, and tunnels) made in the territory of ATU Gagauzia (the maximum annual amount an agricultural producer can request and receive under this measure is 40% of the value of the investment, but not more than 400 thousand MDL);
- Horticulture stimulating investments in founding, updating, and cutting perennial plantations, including grape and fruit in the territory of ATU Gagauzia (the amount of the subsidy shall be calculated as the amount expressed as a fixed amount per unit of usable area from 15 thousand MDL/ha 25 thousand MDL/ha, and the maximum subsidy shall not be more than 300 thousand MDL);
- Procurement of agricultural machinery stimulating investments in the purchase of agricultural machinery manufactured and/or assembled in the territory of ATU Gagauzia (the amount of support provided shall be calculated as a compensation in the amount of 20% of the cost (per unit), but not more than 200 thousand MDL per recipient);
- Equipment and technological re-equipment of livestock farms stimulating investments in equipping and technological re-equipment of livestock farms in the territory of ATU Gagauzia (the amount of the subsidy shall be calculated as 20% compensation for the cost of construction, new technological equipment, and building materials according to cost estimates);
- Purchase of breeding animals stimulating investments in the purchase of breeding animals such as beef cattle, sheep, goats, and foundation stock, super-elite and elite reproductions in the territory of ATU Gagauzia (the amount of the subsidy shall be calculated as compensation for the cost of the animal or foundation stock of field crops of elite reproductions according to the invoices, at the rate of 25%);



Processing of agricultural products – stimulating investments in the development of the infrastructure of the full cycle of post-harvest treatment and processing of agricultural products in the territory of ATU Gagauzia:

- a) primary treatment, calibration, sorting, packaging, cooling, and storage of fruit, table grapes, and vegetables;
- b) slaughter, primary treatment, cooling, packaging, freezing, and storage of meat (beef cattle, small cattle);
- c) processing, packaging, and storage of milk and dairy products (beef cattle, small cattle).

The amount of the subsidy shall be calculated as compensation in the amount of 20% of the cost of construction materials and installed equipment, but not more than 1.5 million MDL per recipient.



Procurement of irrigation systems – stimulating investments in the purchase of drip irrigation equipment for perennial plantings and closed soilvegetables in the territory of ATU Gagauzia (the amount of the subsidy shall be calculated as compensation in the amount of 40% of the cost of the new installed drip irrigation system/micro-aspiration system installed in an area no less than 0.03 ha, but not more than 1.0 million MDL per recipient);

The company has a distribution network of 430 outlets. The milk products are distributed locally and to other destinations in Moldova.

Azamet Pro started its activities in 2007 in Ceadir-Lunga City. The company produces cold pressed oil from grape seeds and gluten free flour using the raw material from local producers. At this moment, Azamet Pro has 30 employees and it reaching an annual turnover of 19.5 million MDL. The main export markets are in the local market of Moldova, the EU and CIS countries, as well as the countries of the Asian region.

The holding consists of independent companies, the activity of which includes many areas of agro-industrial sectors, including farming, processing and storage of grain, production of flour and vegetable oil, trade with all Mediterranean countries, as well as export to countries such as Kazakhstan, Russia, Ukraine and imports from USA. The number of employees is 157 people.
